

## 2009 Application for a Great Lakes Division Permanent National Number

The purpose of the assignment of a permanent national number is to assist the competitor in his/her participation in the Great Lakes Division National Race Program and to aid the race administration in all specialties with participant consistency event to event. Please note, that there is a **\$10** fee for applying for a permanent number. Proceeds from this will go to support the Divisional Driver's School. The Division views this support as crucial to the continued success of the Club Racing program. The following guidelines have been established for national numbers:

### Race Groups

- Group 1 – AS, BP, ST, T1 ,T2
- Group 2 – F500, FF, FV
- Group 3 – SRF
- Group 4 – GT1, GT2, GT3
- Group 5 – EP, FP, GP, GTL, HP
- Group 6 – CSR, DSR, FA, FB, FC, FE, FM, S2000
- Group 7 – DP, SM, SSB, SSC, T3

### GENERAL GUIDELINES:

- This is open to all Drivers with an SCCA National Competition License with your **region of record** in the Great Lakes Division.
- All requests must be submitted in an email or in writing and will be honored by postmark date.
- National number assignment does not supercede individual race supplemental regulations or the GCR.
- **Expiration** of an assigned national number: Once a number is assigned to you, you retain "ownership" of that number for one season ending **March 1<sup>st</sup>**.
- 2008 numbers have priority over 2009 until **March 1<sup>st</sup>, 2009**. After that date, the numbers will be on a first come, first serve on open numbers.

### TO APPLY FOR A PERMANENT NATIONAL NUMBER:

**Current and New Number Applicants:** A completed application (form below) must be emailed or mailed to me. Email requests are accepted provided a check or money order is received 2 weeks after your request. No \$10, no number.

**Confirmation:** If you enclose a self-addressed stamped envelope or an e-mail address, you will receive acknowledgement of your permanent national number.

**Payment Information:** A check or money order for **\$10 made payable to Great Lakes Division, SCCA**.
